 The Board approved Ka 'Umeke's administration to move forward with negotiations to purchase the property located at 124 Maka'ala St. The Board noted that negotiations and any potential offer take into account the leasehold aspect of the property and that the purchase price and offer is not to exceed asking price.

- **3.2 Keaukaha Utilities:** Ka 'Umeke had an outstanding balance for utilities at Keaukaha School dating back to 2014. Ka 'Umeke was able to confirm with DOE Auxiliary that we would not be charged for the use of utilities. A formal letter will be provided to the school.
- **3.3 FEMA FUNDS:** The Board was notified that Admin is working with representatives from FEMA to get a reimbursement on expenses that were incurred as a result of the erruption at the end of the 17-18 school year.
- **3.4 Enrollment Update:** Board was provided with most recent enrollment numbers. Ka 'Umeke has had a steady enrollment of about 205 students for the last 3 years.
