**4.1 Po'okumu report:** The Po'okumu reported on the following:

- 1. Legislative Work: A number of bills related to charter schools will be introduced in the next legislative session. These include bills around funding for facilities, school food service, and transportation. Po'okumu to share electronic drafts of related legislation.
- 2. Accreditation: Work has begun for renewal of accreditation with committee meetings occurring each Monday and Kumu Poki'i Seto being the lead. Substantive change visited for addition of grade 9 and 10, and the new facilities at Kuawa St. are scheduled for November 7, 2018.
- 3. Permanent Facilities: We continue to look at additional facilities options both inside and outside of Keaukaha. We are on hold for purchase of Karma's waiting on response from seller regarding their work with DHHL to transfer the lease. Questions about costs for KS land and whether we want to continue to invest funds into that property.
- 4. SIG Update: SIG continues to focus on language arts learning targets with math becoming the focus in January. Continue to work on coaching. All SIG funds will be spent out by the end of the grant period
- 5. HR Issue: Board heard in executive session regarding a grievance.
