2.4 The current status of SB813 HD1 CD1 is, "Adding more Auditors to the list for charter schools has been passed out by the Legislature and now must be reviewed by the Governor. The Governor has <u>until mid-June</u> to decide whether to veto, sign into law, or allow the bill to become law without his signature." On the Commission's website is posted an RFP for their own 2021 audit but there is no RFP for additional audit firms to respond to in order to be able audit the Schools. Carbonaro (Auditors for the last 10+ years) have decided to prepare and provide an engagement letter us if we specifically request one for the June 30, 2021 year-end audit.
